Raise handle.

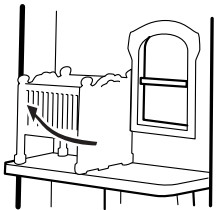


Turn handle to raise and lower elevator.

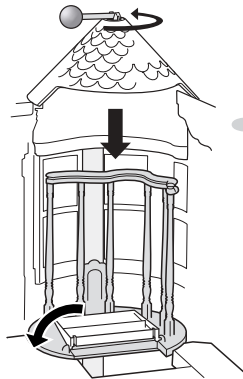


Swing ramp down and lower handle.

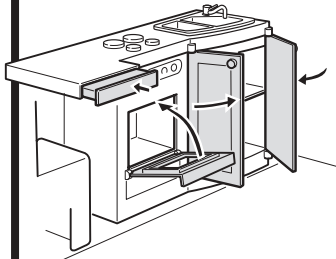


Swing crib back against wall.

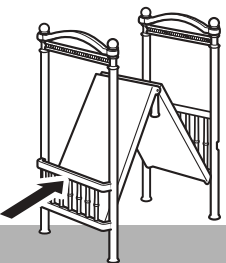
